DESCRIPTION OF CHANGE

Diodes Incorporated (Diodes) on 11/30/2020 announced the completion of its acquisition of Lite-On Semiconductor.

As part of the integration of Lite-On Semiconductor into Diodes this PCN is being issued to notify customers that Diodes is in the process of standardizing and changing from Lite-On Semiconductor product and shipping labels and boxes to the Diodes standard for labels and boxes affecting all former Lite-On Semiconductor products.

Products currently using the Lite-On Semiconductor label format or boxes will ship until supply is exhausted. During an interim transition period, some shipments may also have both labels attached.
